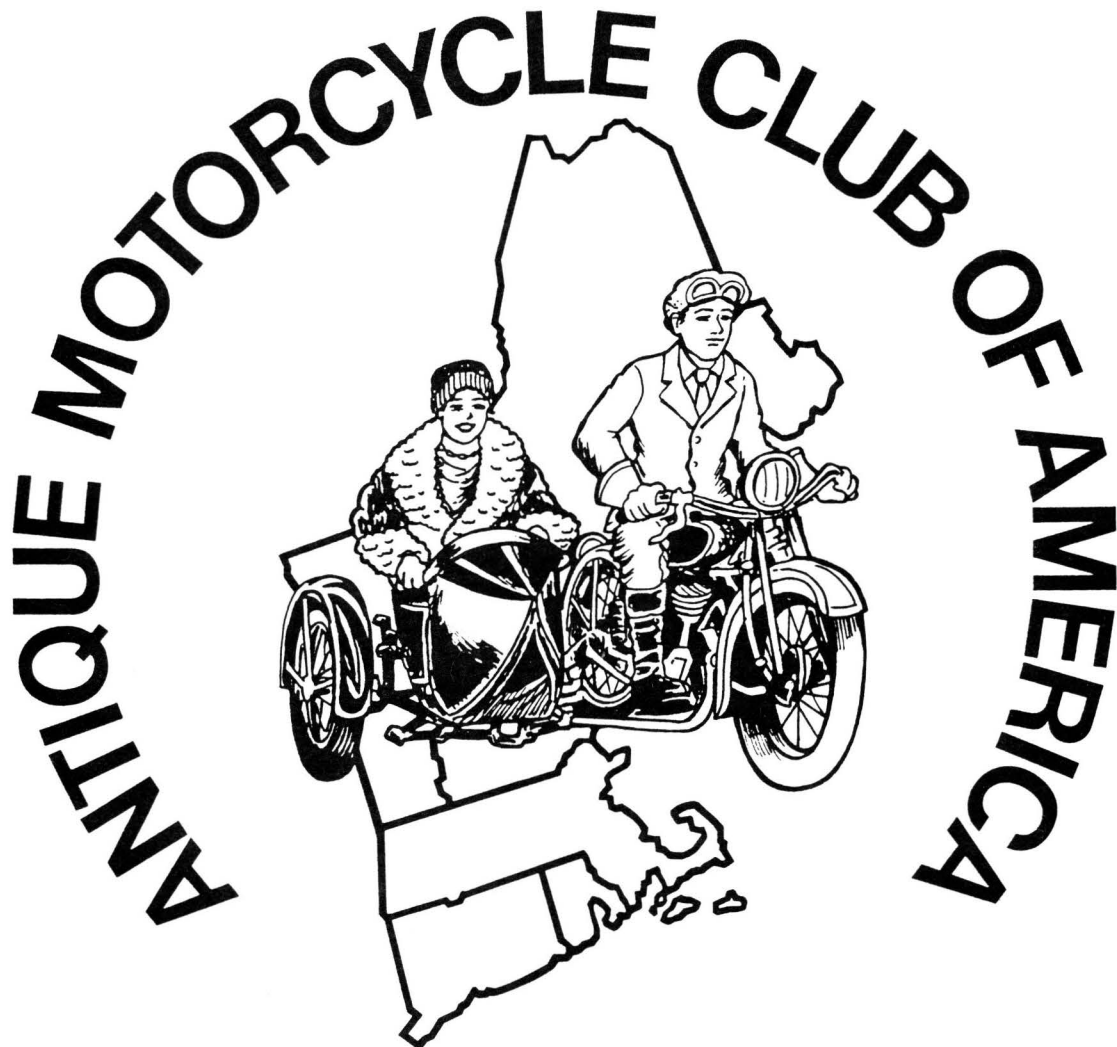

NEWS ITEM: Older (A-hem!) YANKEE Chapter members will recall that the Larz Anderson Museum of Transportation hosted as many as 10 of YANKEE'S early meets (1972-1977), including three NATIONALS.

Larz Anderson reopens May 18

The Museum of Transportation at Larz Anderson Park, Brookline, reopens Saturday, May 18, for the second season of its third incarnation. The theme for the 1985 presentation is: "Fast and Flashy, a Sports Car Celebration."

The museum began life at Larz Anderson Park in what was the carriage house of the Larz Anderson estate. For a time it made its home in a renovated brick structure it shared with the Children's Museum at Museum Wharf. Financial and other problems forced the museum to close, and after a financial overhaul and a substantial paring of the collection, the core collection returned to its original home at Larz Anderson Park last year.

In addition to sports cars, the museum is also celebrating the 100 birthday of the automobile (although it is not possible to pinpoint the exact date or even year when the auto made its debut). A series of party scenes recreating the moods of gala events throughout the last 100 years and 25 examples of the best in sporty cars will make up the display. Included will be 1912 Mercer Raceabout, a Mercedes SL Gullwing and 1968 Lamborghini.

The museum is scheduled to be open Thursday through Sunday, 10 a.m. to 5 p.m.

NATIONAL News

RULES EXPLAINED

In an effort to clarify certain applications of set rules and regulations of the National AMC of A the following explanations are offered regarding questions which have arisen:

"ALL MACHINES ENTERED FOR JUDGING MUST RUN"

This is a National AMC of A regulation and all contestants or entrants in any of the judging classes at any AMC of A or Chapter meet should understand that every machine entered has to be able to run - and the judges may request proof of such capability. There is, however, some flexibility regarding this rule which allows the judges to exercise the right of waiver. For instance, if the machine being judged has been observed in operation at the meet, or if someone has been seen riding it around the area, and the judges are aware of these facts, they may set aside the "must run" requirement. Also, as in the case of judging competition machines, where circumstances might prove dangerous in firing up a "hot bike", but about which the judges have sufficient reason to believe the machine is complete and will run, they may waive the rule. In ALL instances, regardless of extenuating circumstances, it must be understood that the decisions of the judges are final.

PARTICIPATION in Chapter events

Participants in Chapter events must be members of National AMC of A; however, all National AMC of A members may participate in any Chapter event without belonging to the sponsoring Chapter.

POWER CYCLE CLASS Addition

Minutes of the YANKEE Chapter Officers' Meeting

held at the home of Chuck Schmidt

in Florence, Massachusetts

January 27, 1985

YANKEE Chapter Officers in attendance at this meeting included:

The meeting came to order at precisely 1:13 PM at the call of the Chapter Director, John Pierce.

Among the many items discussed, hashed over, deliberated upon, and decisions made about, were:

1) Chapter Logo. A few minor changes were agreed upon before final approval was made.

2) YANKEE CHATTER No. 85-1. A long and pleasant discussion of the "new" newsletter followed and brought forth many ideas as to how YANKEE Chapter can benefit by this excellent form of communication. Among these was the establishment of a "target date" schedule for submission of ads and other material; also, it was felt that members should be advised not to be shy or reluctant to submit any material (to the Editor) including their FREE ads, any vintage ads, technical literature, etc.; and all members should feel free to contact any Chapter Officer at any time about anything.

3) Judging Sheets. There was much discussion on this subject and it was finally concluded that every entry at the Acton, Maine NATIONAL Meet should be given a judging sheet, so that participants may know exactly where they stand. This procedure, hopefully, will also encourage the judges to include British and other previously un-noted machines in the judging categories.

4) Judging. It was deemed advisable to request that sometime before the meet, YANKEE Chapter members who are interested in judging should contact:

5) pre-1954 Machines. All pre-1954 makes and models of machines will be eligible for judging and participants are encouraged to enter as many as possible. Our Special Interest Class was tabled for further discussion at our April 14, 1985 Business Meeting.

6) Officers' Duties. It was generally agreed that all officers should prepare and submit to the Chapter Director, an outline of their particular job, detailing its duties and responsibilities, so that in the future, newly-elected officers may have some form of criteria by which to be guided. (Perhaps a procedural manual - "How to Run a Chapter", can be developed at a later date).

7) American Flag. It was decided to solicit through the newsletter as well as other sources, an American Flag to be used at Chapter and National Meets. Particular use would be made at the Acton, Maine NATIONAL Meet since there is a large water tank in the vicinity with a huge foreign motorcycle ad displayed upon it, and the Flag could be draped and displayed over it. SO-o-o. .if anyone has a large American Flag and can donate it to the Club, it would be appreciated.

8) Camping at Acton, Maine Fairgrounds. As noted in the previous issue (YC No. 85-1) camping will be \$ 5.00 per site for members only and their guests. This

was further explained to indicate that this \$ 5.00 will allow two (2) adults [children FREE with camping parents]; and members will be responsible for their guests. Vendors who camp will be allowed two (2) people with their site.

9) Citizen Band Radios. The use of CB radios as an aid to security at the Acton, Maine NATIONAL Meet was discussed and Club members are asked to volunteer their equipment and services for this purpose.

10) Security and Admission Procedure. After much talk on this subject it was decided to use wrist bands to indicate that all proper and necessary paperwork had been completed.

11) Track Restrictions. This matter was left with Bob Peirce and his crew to administer paperwork, rules and necessary track use waivers. Everyone's cooperation and attention to track procedure is encouraged.

12) BANQUET - Saturday Evening. The Banquet will consist of char-broiled chicken and Jesse will need as many volunteer assistants as she can get. Members who have not yet contacted her (as requested in YC No. 85-1, p. 4) are urged to do so:

13) 4H Club Concession. This project is in the works for breakfast and lunch on both days (Saturday and Sunday). Our Secretary/Treasurer, Charlene Peirce is already handling this matter.

14) Trash Removal. A local resident of Acton, Maine, who has a large truck will handle this chore at a minimal cost to the Club, and this has already been arranged.

15) Police Security. It was noted that the local police are pleased that we are returning to their area. The only complaint about last year's meet was that there was not enough local publicity - otherwise attendance would have been greater.

16) Program of Events. It was decided to hand out a Program of Events at the entrance gate, and this will be worked out by Charlene Peirce and Fred Hirsch.

17) Display Building. John Pierce will handle any and all items which anyone may wish to show only, or to display for general interest. These will be housed in a secured building on the Fairgrounds. Contact him for further information and details:

19) Business Meeting Agenda - April 14, 1985. A tentative agenda was drafted to serve as a general guide for discussion and action with perhaps a few additions.

20) Official Procedure. All officers were advised that all official YANKEE Chapter matters of business will be submitted to the Chapter Director for his information and final approval.

The meeting was adjourned at 8:47 PM, with a vote of special thanks to Chuck Schmidt and Kate for hosting this meeting with their generous hospitality and good food.

Minutes of the YANKEE Chapter Business Meeting
held at TOKEN'S LOUNGE, Southampton, Massachusetts

April 14, 1985

Chapter Director John Pierce opened the meeting at 1:03 P.M. by emphasizing the importance of our YANKEE Chapter in hosting a National AMC of A meet, commenting that we might be able to set an example for other chapters who may wish to hold National meets of their own in the future.

Secretary Charlene Peirce gave a quick run-down of the agenda for this meeting and the first item which came up for discussion was our Special Interest class. After much pro and con deliberation it was voted to have a Special Interest area at the Acton National Meet; but no judging will be performed and no awards will be presented.

George Yarocki then advised us that we must obtain signed liability waivers from all participants in the field games because of the requirements and protection afforded by our National insurance policy.

A long discussion about non-licensed drivers followed and we learned that it is a National rule, in order to comply with insurance regulations, that no unlicensed drivers may operate any motor vehicle at the Meet; looks like there's not much we can do about that, and we certainly don't want to jeopardize our chances of holding future meets.

John Pierce then spoke about the Special Displays and the availability of a building at Acton in which to house them.

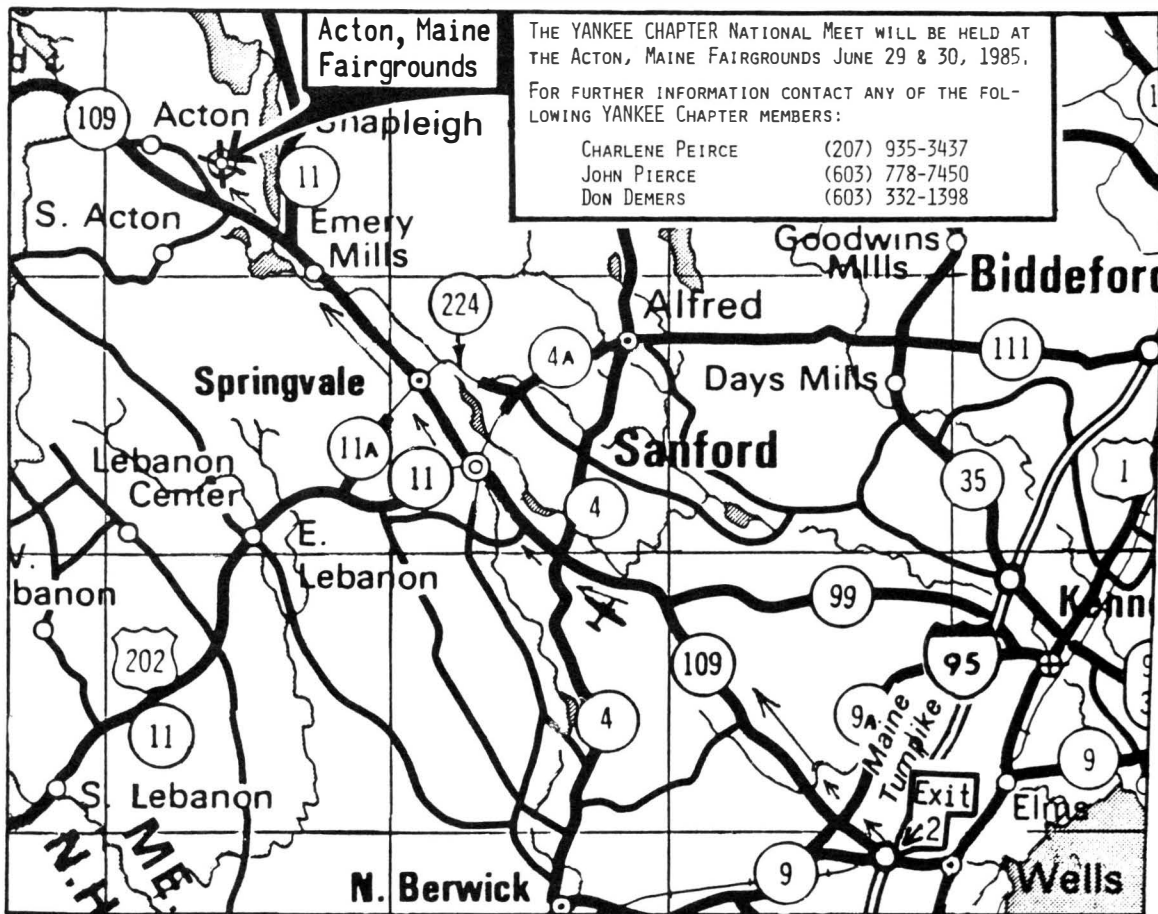

RULES for NATIONAL MEETS

The following rules were adopted at the National AMC of A Board of Directors' Meeting in St. Louis, Missouri on November 3, 1984 (see also YANKEE CHATTER, Fall 1984 Issue, p.10), and are repeated here for the general guidance and information of all concerned:

- 1 - All Vendors must be AMC of A members.
- 2 - Vendors may sell only pre-1954 motorcycles and motorcycle-related parts.
- 3 - Camping is reserved for AMC of A members and their guests only.
- 4 - Ground Fires are not allowed.
- 5 - Alcoholic Beverages are not allowed.
- 6 - Pets must be under restraint at all times.
- 7 - Parents must supervise their children at all times.
- 8 - Track (where available) may be used only by licensed AMC of A members on pre-1954 machines after signing a waiver of responsibility and agreeing to abide by established rules.
- 9 - Unlicensed riders may not operate any motor-driven vehicle at any time.
- 10 - Quiet will prevail after 11:00 PM.

THE ANTIQUE MOTORCYCLE CLUB

What it is . . . What it does . . .

Q. What is the Antique Motorcycle Club of America?

A. The AMCA is a non-profit organization composed of a group of persons interested in Antique motorcycles.

Q. What is the object of the AMCA?

A. The primary objective of the AMCA is to encourage the seeking out, restoration, preservation and exhibition of Antique motorcycles of all kinds.

Q. What is meant by "Antique Motorcycle," as defined by the Club?

A. The AMCA considers any motorcycle manufactured up to and including the 1953 Model Year as an antique, eligible for judging and competition at National Meets. Later machines are welcome, but are not eligible for judging.

Q. When was the AMCA first organized?

A. The Club was founded in 1954 by a group of interested motorcycle owners. It now numbers over 2,100 members and has a worldwide membership. Club membership has always been open to all enthusiasts and interested persons. No restrictions have ever been set regarding race, creed, color, nationality or country of residence.

Q. Is the Club limited to actual owners of Antique motorcycles?

A. No. Any interested person may join with the expectation that he or she will eventually become the owner of an Antique motorcycle.

Q. What do I get when I join the AMCA?

A. You will receive your membership card and you will receive the Club publication which is issued 4 times each year. You will be entitled to participate in all Club activities, such as local Chapter membership and National Meets when they are scheduled.

Q. What is the Club Publication?

A. The publication is an informal magazine published 4 times per year, and contains histories of famous makes of motorcycles, articles written by members, pictures, news of Club Activities, and sections devoted to "wanted," "for sale," and "swap" notices. As a member, you may insert your notice free of charge in each issue (not more than 70 words per issue).

Q. When and where does the Club hold meets?

A. In the past several years, Meets have been held in various parts of the country. You will be notified when and where any such meet will be held.

Q. Are there local Chapters of the Club?

A. Yes. At the present time (1984) there are approximately 20 sanctioned Chapters with several more applications for charter being processed. You are encouraged to become active in the one closest to your area.

Q. When do members have the opportunity to exhibit and operate their Antique Motorcycles?

A. AMCA Meets always include a suitable private road or area where members may operate their machines without registration.

Q. Are back issues of the Club Publication available?

A. Our Secretary usually has a few issues of the publication available. Also available are illustrated bulletins, decals, watch fobs and similar items of Club paraphernalia.

Q. Who is the Club Secretary?

Q. Who is the Club Treasurer?

A. E. E. "Bud" Cox, 3431 W. 10th Street, Wichita, Kansas 67203.

Q. How do I go about joining the Club?

A. By sending one years dues, check or money order, in U. S. funds only, to the **Treasurer**, "Bud" Cox. He will issue your membership card and notify the Secretary who will place you on the mailing list to receive all Club publications and mailings. Membership runs from Jan. 1 through Dec. 31 each calendar year, and includes all 4 publications for that year. For any further information, contact the Secretary.

Q. Is vendor pre-registration necessary?

A. Yes. Starting in 1983, all vendors are required to pre-register for all national meets, or to pay an additional charge for meet-site registration.

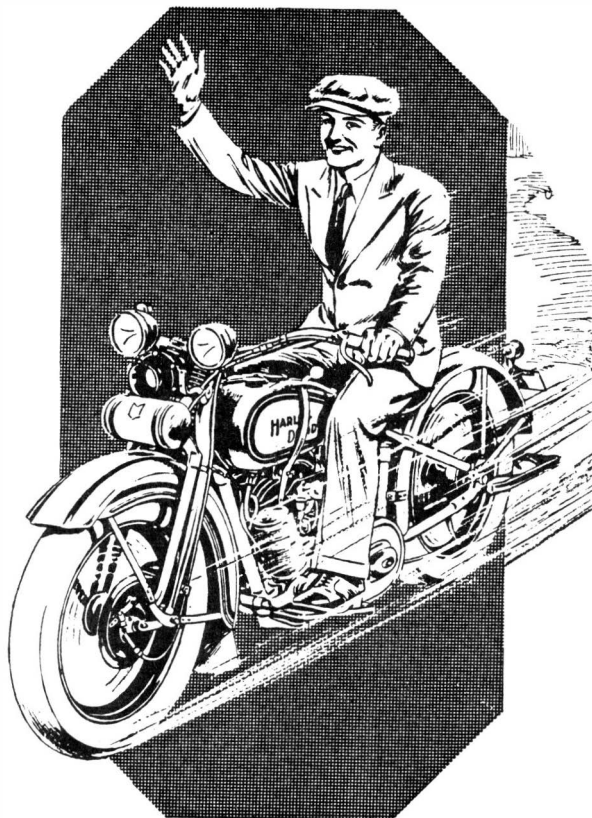
