


# DECEMBER CHRISTMAS PARTY 1992



Plans for this year's two Chapter meets were made as well as plans for a possible National meet in 1994. We will be trying out a new meet sight this summer in central Connecticut.


We hope that you and your family had a great holiday season and that we're all riding together again this spring. -Marty & Maureen

YANKEE CHATTER is the official newsletter of the YANKEE Chapter of the Antique Motorcycle Club of America, and is published four times a year on a seasonal basis: WINTER. SPRING, SUMMER and AUTUMN. The YANKEE Chapter of the AMC of A was established April 8, 1973. Dues for the 1992 membership year are \$ 10.00 single; \$ 12.50 with spouse. Membership is not transferable and dues are not refundable.

Applicants wishing to join the YANKEE Chapter must FIRST be members in good standing (paid up) of the National AMC of A; however, applicants may apply for both memberships to the Chapter Treasurer at any time, and memberships received after October 31st of any year will be held over for the next membership year. National AMC of A membership dues for the 1992 membership year are \$ 20.00 single; \$ 25.00 with spouse. A \$ 1.00 service charge is made for handling an applicant's National application.

Distribution of YANKEE CHATTER is to members of record in good standing (paid up), officers and directors of the AMC of A, and certain editors and other officers of the AMC of A Chapters. As a member of the National AMC of A, YANKEE Chapter is a non-profit organization.

#### Minutes of the YANKEE Chapter Business Meeting held at the V.F.W. Post No. 10284 in Moosup, Connecticut December 6, 1992

(In the absence of our Secretary, Andrea Downs, these notes were compiled by Charlie Gallo.)

The meeting was opened by Director Jessie Jacaruso at 1:00 P.M. A report was given regarding the executive committee's visit to the Berlin fairgrounds and the Durham fairgrounds. In response to this report a suggestion was made to schedule a Chapter meet at the Berlin site in 1993 and a National meet in 1994, pending acceptance by the Berlin Lions Club.

Alex Olearos posed a question regarding how we can expand our organization. A number of suggestions were presented from the floor including placing ads in magazines such as Motorcycle Collector, Antique Cycle Review, Old Bike Journal, and Hemmings Motor News. It was also suggested that we contact motorcyclist rights organizations concerning ads in their newsletters. Jessie stated that we have sent fliers to Harley-Davidson dealers prior to our past meets. Alex agreed to investigate these possibilities further and to report his findings to the executive committee. George Yarocki suggested sending out postcard reminders to people who had let their membership lapse.

Fred Hirsch presented a Treasury Report and also detailed how our membership had remained fairly constant in recent years.

George Yarocki reported that the National Board of Directors was quite impressed with the professionalism and thoroughness of Fred's reports to them. The National Board voted 14-1 to increase vending fees from \$25 to \$30 at all National meets. George voted against this increase. The fee will remain \$25 at our Chapter meets.

Paul Coleman suggested investigating divine intervention to provide good meet weather.

On that note, Jessie adjourned the meeting at 1:13 P.M. and those present settled down to enjoy the great pot-luck dinner and camaraderie that mark our annual get together. TREASURY REPORT - December 8, 1992

# **IN MEMORIAM**

#### EMMETT MOORE

Emmett Moore, the last surviving member of the four founders of the ANTIQUE MOTORCYCLE CLUB of AMERICA, passed away at his home in the town of Florida, New York after a short illness on November 16, 1992, he was 81.

Emmett was the advertising director for the once powerful Indian Motocycle Company, and he was their contact with the Eastern Allied Motorcycle Dealers' Association, which included most of the area's dealerships selling foreign-built motorcycles. When Indian closed, Emmett went to work for BSA, Inc. of Nutley, New Jersey; and later he joined Kawasaki Motors Corp., in Avenel, New Jersey from whence he retired.

In 1954 he was the youngest of the four founders of the AMC of A, and he served as Secretary for many of its formative years. He was closely associated with the "101 Association", which is a group specializing in the restoration of Indian "Scout" models.

Emmett's wife, Betsy, passed away in July and he is survived by his son, Michael.

#### GEORGE W. ALDRICH

We regret to report to our YANKEE Chapter members the death of our New Hampshire member George W. Aldrich as reported to us by his widow. George and Mrs. Aldrich joined our ranks in 1985 and continued their joint membership in both the NATIONAL AMC of A and our Chapter through 1992.

Members who attended our YANKEE Chapter Meet in Acton, Maine on June 23-24, 1990 will recall that George's 1958 Harley-Davidson with Sidecar took the award for Best Restored in the Special Interest Class (See p. 3 YC No. 90-3 Summer 1990).

Mrs. Aldrich has decided to retire from further participation in both organizations.

### New AMC Of A Membership/Magazine Policy

ALL Memberships, renewal and NEW are valid through the end of the calendar year. Renewal memberships are due and payable beginning on January 1.

Any member who waits until the middle of the year or at any time after February 15 of any year henceforth to pay his AMC of A renewal dues; and any NEW applicant whose AMC of A membership is submitted during the calendar year issuance of any of the seasonal issues of "The ANTIQUE MOTORCYCLE" for that year will receive ONLY the issues not yet published. This means that late-joiners, renewal as well as NEW, will forfeit those issues which have already been released, and there will be NO REFUND for these lost issues. They will have to be purchased separately.

Many members do not renew their dues by mail, but wait until they attend a Chapter or National Meet. If you are in the habit of doing so and do not pay your renewal dues before February 15, you will NOT receive the Spring issue; AND, depending on how long you put off paying them, you may also lose the Summer and possibly the Autumn issues as well, in which case you will need to spend extra money to obtain them.

To further REMIND you and URGE you to pay early, the following is quoted from page 35, WINTER Issue 1992, "The ANTIQUE MOTORCYCLE", Vol. 31, No. 4. This new policy was approved and adopted at the September 3, 1992 Business Meeting of the AMC of A:

"...beginning in 1993 the date of renewal or date of a new member joining, would determine the first issue to be sent out. New or renewing members would receive the remainder of the year's magazine, beginning with the next regularly scheduled magazine mailing. Earlier issues of the magazine would be available for purchase from the Secretary. The vote was unanimous. This means that all members should be encouraged to send in their renewal notices promptly, and that any not received by February 15, 1993, would not be on the Spring 1993 magazine mailing list."

Also, for those who renew their memberships each year, there is a special note on the 1993 AMC of A renewal form:

"NOTICE: Dues must be paid by February 15th if you are to receive all four issues of the Antique Motorcycle."

In recruiting NEW applicants, members are cautioned to be sure to make this procedure known to anyone wishing to join the AMC of A.




